RE: INVITATION TO AN INTERACTIVE AND CONSULTATIVE CONFERENCE TO ASSESS THE STATUS OF THE ONGOING CAMPAIGN TO REVITALISE AND RE-ENERGISE REGULATORY AUTHORITIES AND AGENCIES (RAA) AGAINST THE BACKGROUND OF EMERGING ISSUES

This Office has scheduled the above **Conference to be held at the Kenya School of Government, Mombasa from 11th Thursday – 12th Friday April, 2024 commencing at 8.30 am.**

This Conference is part of a series of continuous engagement fora with various cadres of public officials aimed at outlining the Administration's expectations clearly, and reinforcing the performance standards expected of you in order to achieve optimal performance in the execution of mandates by RAA under your ward. In addition, this engagement is expected to headline the urgency for actions required of RAA as key agents of the change envisioned under the Bottom-Up Economic Transformation Agenda (BETA). Further, recent incidences reported in the public domain have reinforced the critical role of RAA in: preserving and/or improving the quality of life and livelihoods; prevention of destruction of property and businesses; and the inexcusable lowering of the quality of goods and services delivered to the public.

The Conference is expected to be interactive as various actors involved in the regulatory process make presentations that highlight emerging best practice and new learning from their experiences. It is expected that the challenges faced therewith by RAA will also be discussed candidly with a view to seeking ways and means to elevate the performance of RAA in order to better serve Kenyans. The presenters and discussants of papers at this Conference will be drawn from among the actors in the regulatory space including: Principal Secretaries, Chief Executive Officers, Chairs of Boards, Chairs of the Standing Committees on the Revitalisation and Re-energisation of RAA, and standards and enforcement bodies that ought to work closely with RAA. In this regard, this Office shall communicate further details. Principal Secretaries are required to attend this Conference while accompanied by the **Chairs of Boards and Chief Executive Officers of the Regulatory Authorities and Agencies under your ward, a list of which is attached to this communication.**


